Party Qualification

Open to Supervisors who accumulate 15,500 TVP in 3 consecutive months*

OR

Open to Supervisors who achieve 2,500 TVP* in 3 consecutive months** AND:

Have at least two personally sponsored non-Supervisors*** who achieve 500 PPV in 3 consecutive months*

OR

Have at least five 2017 ASP Stones**

All 15K President's Team and above are automatically invited to host the party.

*Qualification period: May - September 2017.

**Requirement of minimum 2500 TVP in 3 consecutive months* is a prerequisite in each Party qualification method.

***All non-Supervisors (even previous MAP qualifiers), who achieve 3x500 PPV in qualification period, are counted as contributing to upline Supervisor Party qualification. The 3x500 PPV of contributing Member do not have to be achieved in the same 3 months as 3x2500 TVP of qualifying Supervisor.

****ASP 2017 Qualification: Earn 2,500 Total Volume Points in each of 3 consecutive months (May 2016 - September 2017). For each Active Supervisor in your Downline, qualified in the same 3 months as yourself, you will be awarded a Stone in your pin. Blocking rules apply.

Note: To attend the party you need to purchase the Extravaganza ticket. Your Spouse/Partner will need to have an Extravaganza ticket as well (even if they only plan to attend the Party).

Visa & Travel Information

Herbalife can issue a letter that might help you obtain your Visa, but it is ultimately the Member's own responsibility. For details please contact your local Member Services Team.

You will need a valid passport or ID to travel to South Africa (unless you are a resident there). All attendees must be in possession of a valid travel documents. Passports, visas, proof of citizenship, expiration date of passport, and all other travel documents required for the African Herbalife Extravaganza are the sole responsibility of the qualified Member and not Herbalife.

The nearest airport is O.R. Tambo International Airport.

Divorced Members

Each individual ID may utilise 100% of the Total Volume points from the original ID towards a Volume Point qualification.

Note:

If they achieve the qualifications under their individual Membership only, they will be awarded 100% value of rewards.

However if they achieve the qualifications by combining points under their own ID and under the Original ID, each individual will be awarded 50% value of rewards, or as determined by their legal agreement. I.e. if there is a cabin they would get 2, but would have to pay 50% of the cost. If there are 2 pens then they would get 1 each. In addition, they would not be entitled to get this for them AND their new partners unless, they also qualified on their new ID's. However, if it is a meal then typically their guest can come along too.
